• Reimbursement of the guarantor's insurance premium	In accordance with the guarantor's rate (excluding VAT, with the subparagraph 196.1.3 of paragraph 196.1 of Article 196 of the Tax Code of Ukraine)
• Preparation and completion of the T1 customs declaration	Agreed (the cost depends on the amount of customs duties and the number of commodity items)*
• Ensuring payment of customs duties under the simplified "use of the general guarantee" procedure of the Contractor/Freight Forwarder	Agreed
• Labeling of goods (application of 1 sticker provided by the Client)	Agreed (but no less than UAH 900)
